NOTICE-CUM-ADDENDUM is hereby given to all the investors of the Scheme, in terms of enabling provisions of Regulation 33(4) of SEBI (Mutual Funds) Regulations, 1996, for rolling over (extension of maturity date) of the Scheme. Pursuant to provision to Regulation 33(4) of SEBI (Mutual Funds) Regulations, 1996, it is proposed to roll over (extend the maturity date) the Scheme to May 31, 2018. The existing maturity date is

- 1. Purpose The purpose of the roll over (extension of maturity date) is to continue to benefit from the prevailing yields in the fixed income market taking into consideration the current economic and regulatory environment.
- 2. Period 120 days. Accordingly, the revised maturity date of the Scheme will be May 31, 2018.
- 3. Extended Maturity Date May 31, 2018 (or immediately following business day if the maturity date falls on a non-business day.)
- 4. Date of Roll over February 01, 2018 (or immediately following business day if the maturity date falls on a non-business day.)
- 5. Terms of roll over (extension of maturity date) Upon roll over of the Scheme, certain provisions of the Scheme stand modified. The existing and modified provisions are stated below:

The tenure of the Scheme would be 120 days from the date of roll over and will mature on May 31, 2018. The Scheme will not have any exposure to Securitised Debt.

- 1. The Scheme shall invest in instruments having credit rating as indicated above or higher.
- 2. In case instruments/securities as indicated above are not available or taking into account risk reward analysis of instruments/securities, the Scheme may invest in Certificate of Deposits (CDs) having highest ratings/CBLOs/T-Bills/Repo and Reverse Repo in Government Securities. Such deviations may exist till the time suitable NCDs/CPs of desired credit quality are not available.
- 3. All investment shall be made based on the rating prevalent at the time of investment. In case securities/instruments are rated by more than one rating agency, the most conservative rating would be considered. In case of downgrades of a particular instrument, the Fund Manager shall rebalance the portfolio on a best effort basis within 30 days, provided such a rebalancing is possible on risk reward analysis.
- 4. The Scheme would not invest in unrated securities (except CBLOs/Government Securities/T-Bills/ Repo and Reverse Repo in Government Securities) and derivatives.
- 5. Post roll over and towards the revised maturity of the Scheme, there may be higher allocation to cash and cash equivalent.
- 6. In the event of any deviations from the floor and the ceiling of credit ratings specified for any instrument, the same shall be rebalanced within 15 days from the date of the said deviation.
- 7. Securities with rating A shall include A+ and A-.
- 8. Further, the allocation may vary during the tenure of the Scheme. Some of these instances are: (i) coupon inflow; (ii) the instrument is called or bought back by the issuer (iii) in anticipation of any adverse credit event. Such deviations may exist till the time suitable NCDs/CPs of desired credit quality are not available, and incase of such deviations the Scheme may invest in Certificates of Deposits (CDs) having highest rating/CBLOs/Reverse Repos and Repo in Government Securities/ T-Bills.

There would not be any variation from the intended portfolio allocation as stated above on the final allocation, except as specified in point nos. 1, 2, 3, 5, 6 and 8.

In the event of any deviation from the asset allocation stated above, the Fund Manager shall rebalance the portfolio within 15 days from the date of such deviation except in case where the deviation is on account of the conditions stated in point 1, 2, 3, and 8 above.

The tenure of the Scheme will be 120 days from the date of roll over and will mature on May 31, 2018.

Non-Convertible debentures/Bonds & Zero Coupon Bonds/Deep Discount Bonds are considered as Traded based on the information provided by external agencies.

The scheme has not transacted in Credit Default Swaps. ** Thinly Traded/Non Traded/Illiquid Securities.

Net Current Assets is adjusted to the extent of short derivatives positions, if any.

Investors are requested to note that during the roll over, the portfolio of the Scheme may be liquidated only to the extent of redemptions/switch-outs requirements under the Scheme and the portfolio may be held/changed depending on the Scheme's investment strategy/prevailing market factors.

Please note that pursuant to SEBI circular No. Cir/IMD/DF/15/2014 dated June 20, 2014 read with Regulation 39(2)(c) of SEBI (Mutual Funds) Regulations, 1996 the Scheme would not be rolled over in case any of the below mentioned conditions are not fulfilled during the roll over process:

1. the Scheme shall have a minimum of 20 investors

2. the assets under management (AUM) of the Scheme is atleast ₹ 20 crore

In case any of the above conditions is not fulfilled, the scheme shall be deemed to have matured on the maturity date. Further, the investors are also requested to note that in case single investor accounts for more than 25% of the corpus of the Scheme post the roll-over, the roll-over application would be effective only to the extent of 25% of the corpus of the Scheme. The extent of exposure in excess of the stipulated 25% limit would be liable to be rejected and consequently such exposure over 25% limit will be refunded.

All the other provisions of the Scheme Information Document (SID)/Key Information Memorandum (KIM)/addenda except as specifically modified herein above remain unchanged. Please refer to the Statement of Additional Information, for updated taxation provision. For more information, you may also consult your tax or financial advisor.

In case you do not consent to the said changes, your investment under the Scheme shall be redeemed at applicable NAV on the existing maturity date. If the units are held in dematerialized form, investors are requested to contact their Depository Participant.

The cut-off time to submit the approval slip or send the consent mail for the rollover is 6 p.m. on the maturity date. Any request received after 6 p.m. will not be processed. Please note that the approval slip or the mail should have Investor's name, folio number and the Scheme name, failing which the roll over request may not be accepted.

In view of the individual nature of the implications, each Unit holder is advised to consult his or her own tax advisors/ financial advisors with respect to the specific amount of tax and other implications arising out of his or her participation in the Resetting the maturity of the Scheme.

The Trustee/AMC reserves the right to change/modify the provisions mentioned above at a later date.
