- 2) Exit load under ICICI Prudential MIP 5 (An open ended income fund. Monthly income is not assured and is subject to the availability of distributable surplus.)*:
 - if units purchased or switched in from another Scheme of the Fund are redeemed or switched out within 1 year from the date of allotment - 1% of the applicable NAV;
 - ii) if units purchased or switched in from another Scheme of the Fund are redeemed or switched out after 1 year from the date of allotment - Nil.
- *The revision in exit load shall be applicable on a prospective basis to all the transactions including Systematic Investment Plan and Systematic Transfer Plan where registrations / enrolments have been done on or after the effective date.
- 3) Fund manager managing debt portion of ICICI Prudential MIP 5 (An open ended income fund. Monthly income is not assured and is subject to the availability of distributable surplus.)

The debt portion of the aforesaid scheme will be managed by Mr. Rahul Bhuskute with immediate effect. The qualification of Mr. Bhuskute is Bachelor of Engineering and Master of Management Science.
