The outstanding units in respect of the existing unit holders under the Bonus Option/ Plan shall be continued, without allowing any fresh subscription from the unitholder, till all units under the Bonus Option/Plan of the Schemes have been redeemed and subsequently, the Bonus Option/Plan shall be closed.

Accordingly, SIP transactions under the Bonus Option of the Schemes would also be discontinued from the effective date.

Investors are requested to take a note of the above change.

All the other provisions of the SID/KIM except as specifically modified herein above remain unchanged.
